The annual Report for the calendar year 1st January to 31st December 2012, demonstrates our continued commitment to first-rate the administration and management of the Road Fund and the provision of strategic financial oversight for sustainable socio economic advancement of the country within the overall government's strategic policy direction for the Road Sector.

On that foundation, we repositioned our corporate direction by enhancing Intra-Agency and Inter-institutional Coordination in the Road Sector. This was delivered with the highest level of professional service in our quest to provide adequate and sustainable financial resources to the implementing Agencies and institutions for a 'Good and Safe Road Network'.

I thank the Board of Directors for the guidance and support towards the achievements that I am proud to present in this Annual Report. I pay tribute to the capable and dedicated staff who worked together with enthusiasm to reinvigorate the Agency's core business by harnessing

innovation, improving skills and enhancing the effectiveness of our service delivery.

The Agency's operational focus during the year under review was anchored on its three year Strategic Plan (2011-2013). The 2012 implementation phase followed a structured pattern of indicated Outcomes, Actions, Key Performance Indicators, Means of Verification, Critical Assumptions and specific drivers following stakeholder input that formed an integral part of the review of the Plan from the year 2011.

Guided by the tenets of this strategic plan, the Agency took a proactive role in the mobilisation, management and administration of Road Sector funds, strengthening institutional capacity systems, enhancement of internal audit and risk management systems, and the upholding of corporate governance principles.

As this Annual Report will demonstrate, the Government of the Republic of Zambia has been increasing its investment through the Road Fund for the major rehabilitation, upgrading and maintenance of the road infrastructure in the Country.

The cooperating partners' external Road Fund sources continued to play a vital role in backlog addressing the of periodic maintenance of the road network and the rehabilitation of roads that have deteriorated beyond the level for periodic maintenance. In light of this investment, the Agency has put up systems and monitoring mechanisms to ensure transparency, accountability and efficiency in the use of the Road Fund to get value for money. During the period under review, this was mainly done by project implementation monitoring through officebased project tracking, attendance of project implementation site and physical site inspections to enhance the monitoring process.



At regional and continental level, a significant highlight of the calendar year 2012 was the successful hosting of the landmark 11th African Road Maintenance Funds (ARMFA) Association Annual General Assembly from the 29th October to the 2nd November 2012 at the Zambezi Sun Hotel, in Livingstone. The Annual General Assembly was attended by about 200 local and foreign delegates from the 31 ARMFA member Countries.

The theme of the Annual General Assembly was "Working towards Sustainable Road Maintenance", with a focus on the use of Performance Based Road Contracts (PBRCs). Zambia was used as a practical example of the immense successes of PBRCs as the road maintenance mechanism has the overall improved efficiency to the road sector which translates to better road conditions at lower costs for the governments and reduced management burdens on the road administrations.

Furthermore, the Agency continued to chair the Southern Africa Focal Group of ARMFA and performed its role as Treasurer of ARMFA. The Agency also presented several technical papers at various international fora at which the country's opportunities in the Road Sector were show cased.

Looking ahead, the Agency will continue providing fiduciary oversight on all Road Sector finances in 2013 to meet great expectations from all stakeholders as we strive to provide sustainable funding for key road projects such as link Zambia 8000, Pave Zambia 2000 and L400 whose main thrust is to transform Zambia from a Landlocked to a Land-linked country to tap into the many economic opportunities in the trade corridors. The details of the projects have been highlighted under the Fund Management section of this report.

1.0 INTRODUCTION

The report covers activities carried out by the Agency in 2012.

The Agency consists of four departments namely, Corporate Support, Fund Management, Internal Audit, and Monitoring and Evaluation.

2.0 CORPORATE SUPPORT

The Corporate Support department handles matters relating to Human Resource Management, General Administration, Procurement, Public Relations, Board Affairs and Integrity Committee. This section, thus, gives key highlights on the operations of the department in 2012 under the functions indicated above. Further, a brief on the hosting of the 11th African Road Maintenance Fund Association, (ARMFA) Annual General Assembly is also given under the departmental report.

2.1 HUMAN RESOURCE MANAGEMENT

2.1.1 Staff Complement

During the period under review, the Agency operated with a structure of twenty (25) employees at the beginning of the year and separated with one (1) employee leaving twenty-four employees by the end of the year. All employees served on three (3) years fixed term contracts of service.

2.1.2 PERFORMANCE MANAGEMENT

All employees were subjected to an Annual Performance Evaluation to assess their individual performance.

2.1.3 INDUSTRIAL RELATIONS

The Industrial Relations atmosphere was calm and no industrial unrest was recorded.

2.1.4 POLICY DOCUMENTS

The department was responsible for the interpretation and implementation of the following Policy Documents:-

- ii) Disciplinary Code of Conduct and Grievance Procedures;

During the period under review, all the above documents were revised and updated except for the Administration Manual and HIV/AIDS Policy which were drafted and approved by the Board during the year.



2.1.6 2012 Review of 2011 – 2013 Strategic Plan

Management and staff reviewed the performance of the Agency in 2012 in relation to the Strategic Plan 2011-13. A review report was compiled and the same was to be presented to Stakeholders and the Board in the first quarter of 2013.

2.1.7 Training and Development

Employees attended and participated in various short-term training and capacity building workshops. This was

meant to improve and sharpen skills among employees.

2.1.8 Health and Safety

The department ensured that employees operated in a safe and healthy environment. The Agency operated a medical scheme for all its employees and their immediate family members

2.2 GENERAL ADMINISTRATION

During the period under review, the Corporate Support Department continued to manage Agency assets prudently. Insurance of Agency assets and personnel, service contracts for cleaning, security, information technology and other support services were put in place.

The Agency provided office space to the following:

- i) Public Private Partnership (PPP) Unit, Ministry of Finance
- ii) Monitoring and Evaluation Unit, Ministry of Transport, Works, Supply and Communications; and
- iii) KfW of Germany.

Various Agency assets were managed efficiently. In terms of management of motor vehicles no major accidents were recorded the in year.

2.3 PROCUREMENT COMMITTEE

 The Committee met six (6) times during the year under review and approved internal major procurement requirements of the Agency.



ii) NRFA procured various goods and services that were budgeted for the year under review. Major items whose value was above K50 million were procured through the Procurement Committee. ΑII procurement requirements were supplied during the year under review.

2.4 PUBLIC RELATIONS

The following information dissemination activities were undertaken during the period under review:

2.4.1 Road Site Inspections and Press Coverage

The Agency enjoyed wide coverage on various activities from the print and electronic media. The coverage emanated from media interviews, and press releases.

The Agency conducted site inspections of road projects and related activities countrywide. These road inspection tours provided a platform for information dissemination as they were extensively covered in the mainstream media. A television documentary showcasing the essence of road inspection and the resultant benefit in value for money was also compiled and aired on Zambia National Broadcasting Corporation (ZNBC) Television.

The Agency enjoyed wide coverage on various activities from the print and electronic media, during the period under review. The coverage emanated from media interviews, and press releases.

The Agency also enjoyed extensive media coverage during the hosting of the 11th ARMFA Annual General Assembly from 29th October to 2nd November 2012. A television documentary on the Annual General Assembly was also compiled and aired on ZNBC TV.

2.4.3 Road Fund Corner

A column, dubbed 'Road Fund Corner' was published monthly in The Post Newspapers during the period under review. This interactive column covered a range of Road Sector activities for the information of all stakeholders. Some of the topics covered included the 2012 Road Sector budget, monitoring and evaluation, and road safety activities.



2.4.4 International Trade Fair and Zambia Agricultural and Commercial Show

The Agency participated at both the Zambia International Trade Fair (ZITF) and the Zambia Agricultural and Commercial Show.

The objective of the National Road Fund Agency Integrity Committee (NRFA-IC) which was formed under the auspices of the Anti Corruption Commission (ACC) is to enhance institutional performance by making anti-corruption and integrity the way of life in service delivery.

During the period under review, the Committee undertook the following activities:

- i) Developed a brochure for NRFA –IC;
- ii) IC Activities and contact details were posted on the NRFA Website (www.nrfa.org.zm)
- iii) Developed a Customer Feedback mechanism;
- iv) Developed an Awards/Commendation Policy Document;
- Installed a suggestion Box at the reception area of the NRFA new building;

- vi) Core values were displayed on every floor of the NRFA building;
- vii) IC held two (2) staff sensitization meetings.
- viii) Code of Ethics Booklets for NRFA and Public Service were distributed to all staff;
- ix) Participated at the Integrity in Public Life Forum in April 2012:
- x) Held a focus group discussion on Corruption Vulnerability (identification of hot spots) – in August 2012;
- xi) Participated at the Management Accountability Workshop with ACC;
- xii) Maintained close communication with ACC Desk Officer;

2.7.2 **Conference Theme and ARMFA Objectives**

The theme of the Annual General Assembly was "Working towards Sustainable Road Maintenance", and focus was on the use of Performance Based Road Contracts (PBRCs). This was in line with overall ARMFA objectives which, among others, are as follows:

- i) Developing a network for experience sharing on financing of road maintenance in Africa as well as the operation of the funds;
- ii) Promoting and strengthening of ties between road maintenance in funds in Africa;
- iii) Promoting the proper management of road maintenance of funds;
- Enhancing the capacities of the iv) existing roads, and
- v) Promoting Public Partnership for the mobilization of resources for road maintenance

The ARMFA conference was broken down into three sessions. The first session was a Technical Workshop held from 29th to 31st October 2012 with a site visit to a PBRC project in Choma; the second session was the Annual General Meeting for ARMFA members only which was held on 1st November 2012; and the third session was Tourism Day held on 2nd November 2012, designed showcase Zambia's tourism potential.

2.7.4 **Technical Workshop**

The technical sessions focused on Performance Based Road Contracts (PBRC) with a key note presentation by World Bank Lead Transport Specialist in Africa, Ben Gericke who stated that the concept of PBRCs had proved attractive and, as a result, had spread progressively in many countries the World Bank supported.

It was noted that PBRCs brought an overall improved efficiency to the road sector which translated to better road conditions at lower costs for the reduced governments and management burdens on the road administrations.

Zambia was used as a practical example of the immense successes of PBRCs, as highlighted by Road Development Agency (RDA) Senior Manager Construction and Maintenance Mr. Charles Mushota who defined PBRCs as a measure of the service level where the contractor or service provider was paid per kilometer of a road worked on in compliance to agreed service levels and performance.

2.7.6 **Tourism Day**



3.0 **FUND MANAGEMENT**

The National Road Fund Agency (NRFA) Road Fund has been mandated to manage and administer the Road Fund which comprise two main sources of revenue, namely, Local Resources (Fuel Levy, Other Road User Charges and GRZ project direct allocations) and External Resources from Cooperating Partners.

The Local Resources of Fuel Levy and Other Road User Charges (ORUCs) are contributions by the road users and it is this funding that is dedicated to the routine maintenance of the road network.

The GRZ allocations provide funding periodic maintenance, rehabilitation and construction of road projects.

For the 2012, the total Annual Work Plan and Budget was K4.27 trillion, of which the Local and External Resources Budget were K2.24 trillion and K2.03 trillion, respectively.

3. 1 MAJOR **ACHIEVEMENTS DURING** 2012

The notable major achievements during the year under review were:

3.1.1 **Audit of the Road Fund Accounts**

The NRFA did prepare unqualified quarterly and annual audited Road Fund financial statements for the year ended 31st December 2011 during 2012.

Urban 3.1.2 Road Rehabilitation Programme (URRP)

The URRP was finally completed during 2012 with the success of opening up much of the urban areas of Lusaka and Copperbelt towns.



3.1.3 Launch And Commencement Of The Link Zambia 8,000 Project

The Government of the Republic of Zambia (GRZ) has initiated the **Link Zambia 8000** Programme which is an accelerated road construction programme aimed at transforming Zambia from being landlocked into a truly land-linked country in Southern Africa. The Programme involves upgrading to bituminous standard of approximately 8,000 km of roads thereby linking districts and provinces throughout Zambia.

His Excellency President Micheal C Sata, the President of the Republic of Zambia, officially launched the Link Zambia 8,000 Project Phase I on 20th September 2012. The whole Project is estimated at **K21 billion**.

A total of **K91.09 billion** was disbursed during 2012 under the Project.



3.1.4 Launch of the Pave Zambia 2,000 Project

The Urban Roads Network Paving Blocks Project coined Working on Roads Countrywide ("WORC") or "Pave Zambia 2,000" is the first of its kind and scale in Zambia. The project encompasses segmented paving on approximately 2,000 km of urban roads which are in poor condition requiring rehabilitation. The project has different phases from which the Zambian youth can benefit following the number of jobs that will be created. The phases include; paving block manufacturing, earthworks construction and segmented paving block laying.

The Pave Zambia 2,000 Project was successfully launched during 2012 and a total of **K12.05 billion** equipment contract was signed during the second half of 2012.

3.1.5 Lusaka 400 Project

The Lusaka 400 Project contract was signed during 2012 and a total of K100 billion (US \$18.87 million) was disbursed as advance payment during the Fourth Quarter of 2012. The balance on the advance payment of K172 billion (US \$33.13 million) was to be disbursed in early 2013 so that the Contractor can commence mobilization. This project is meant to enhance connectivity in the city.



3.1.6 Training programme for small contractors through National Council for Construction (NCC)

The NCC was allocated **K5 billion** and received the whole amount in the 2012 AWP by NRFA to commence training of small contractors and persons.

By 31st December 2012, a total of 340 persons were trained in Short Intensive training programmes ranging from one week to 16 weeks in Lusaka and in addition, 450 persons attended one week provincial training workshops with average participation of 45 persons per province, from the target group was 50 per province.

3.1.6 Training programme of Local Road Authorities jointly undertaken by Ministry of Local Government and Housing (MLGH) and NRFA

The MLGH and NRFA conceptualised building capacity of the Local Road Authorities through training fiduciary, technical and monitoring and evaluation during 2012 to prepare them for direct funding from NRFA, other than through RDA. The training for the first districts was planned for early 2013 and it is expected that all districts would gradually be trained in the next two years and should all access direct funding from NRFA as part of the decentralisation programme in road construction as delegated road authorities by RDA.

3.1.7 Construction Finance Initiative (CFI)

The CFI is an initiative which will arrange, fund and build capacity of the Local Road Contractors and

ultimately enhance and grow the road construction industry.

The National Road Fund Agency Road (NRFA) and Development Agency (RDA) successfully commenced implementation of the Construction Finance Initiative (CFI) through stakeholder consultations with the Association of Small and Medium Contractors. implementation of this initiative will continue in 2013.

3.2 MOBILISATION, MANAGEMENT AND ADMINISTRATION OF THE ROAD FUND

The Government of the Republic of Zambia has been increasing its investment through the Road Fund for the major rehabilitation, upgrading and maintenance of the road infrastructure in the Country, as can be seen in **Table 1.** This trend is noticeable when considering




the fact that over the last seven (7) years, over 74% of the total annual budgets for the Local Road Fund from 2006 to 2012 has been released.

There was a drastic fall in receipts during 2012, mainly due to low absorption capacity during the first three (3) Quarters of 2012, which improved during the last two months of the fourth Quarter of 2012.

However, overall the Road Sector absorption capacity has been good averaging 70% over the last seven (7) years.

As noted above, the significant low absorption capacity in 2012 of 60%, falling from 72% in 2011, was due to the following three major factors:

(a) The lengthy procurement process for local and externally financed projects did slow project delivery during the year under review. The procurement process will be fully streamlined effective 1 January 2013 and this



- should increase the absorption capacity during 2013.
- (b) The Road Sector industry development and growth has been negatively affected by low capacity in the local contractor base, which has also a limited number of contractors. The CFI will assist to grow the local contractor base, while enhanced International Competitive **Bidding** will attract International Consultants and Contractors' participation in the bidding process so as to increase the number of Contractors and Consultants in the Zambian Construction Industry.
- (c) The Road Sector has been implementing the increasing annual work plans and budgets with static staffing levels, leading to low capacity levels. The Road Sector Agencies, namely RDA, RTSA and NRFA commenced harmonisation and improvement of staff emoluments during 2012 and this process should be fully completed during 2013, so that the Agencies can have adequately remunerated staffing levels.

Bar Chart 2: Local Road Fund Budget, Receipts and Disbursements from 2006 to 2012



3.2.1 Mobilization, management and Administration of the Local Resources during 2012

There was a noticeable fall in both receipts and disbursement levels during 2012 due to the same factors highlighted above. However, the overall performance over the seven (7) year period – 2006 to 2012 - was above 100% on both mobilization and absorption capacity levels.

Below in **Table 3**, is the detailed summary of Local 2012 Road Fund Budget, receipts and expenditure.

3.3 MOBILISATION, MANAGEMENT AND ADMINISTRATION OF THE EXTERNAL RESOURCES DURING 2012

The cooperating partners' External Road Fund sources continue to play a vital role in addressing the backlog of periodic maintenance of the road network and the rehabilitation of

those roads that have deteriorated beyond the level for periodic maintenance. **Table 4** gives a summary of the External Resources Annual Budgets, Receipts and Disbursements from 2006 to 2012, with mobilization and absorption capacity performances falling from 66% and 48% in 2006 to 39% and 38%, in 2012, respectively.

However, while it has always been agreed and planned that External Capacities noted in **Table 5** were caused by:

- (a) There were some delays in project implementation funded by BADEA, Exim Bank, Kuwait and Saudi Arabia due to delayed fulfillment of Conditions Precedent to the effective commissioning of the projects; and
- (b) The European Union (EU) has been withholding funding to the Road Sector following the 2009 audit. Table 5, is the detailed summary Local 2012 Road Fund budget, receipts and expenditure.



Road Funds should supplement Local Road Funds halfway, there have always been low receipts, mainly due to low absorption capacity. The low absorption capacity is caused by the factors noted above. In addition, the low mobilization and absorption

In detail, the Receipts and Disbursements from External Road Fund Sources by Cooperating Partners were made as follows:

3.3.1 The African Development Bank (AfDB) - Design of the Kazungula Bridge. **Border** Post Facilities. **Corridor Facilities and Transport Facilitation Programme**

> The African Development Bank (AfDB) signed a grant agreement with the Government of Zambia on 7th May 2007 for a total amount of AU 1.45 million to finance the design of the Kazungula Bridge and its Border Post Facilities, Corridor Facilities and Transport Facilitation Programme.

> The Grant proceeds commenced in 2010 for a total of K1.90 billion (US \$396,984.12) which funded the preliminary design report for the Kazungula Bridge Project by Egis BCEOM International at K817 million (Euro 142.292.76) and the Addendum No.2 for the geotechnical investigations by Egis **BCEOM** International at K1.19 billion (US \$250,000). A total of K1.54 billion (US \$295,222) was disbursements in 2012 as shown in Table 5 above, from the balance of K3.41 billion (Euro **500,000)** to be disbursed in 2012. There were delays in commencing the construction of the Kazungula Bridge, hence the low disbursement against the budget for 2012.

The African Development Bank (AfDB) and the Government of the Republic of Zambia has signed a Credit Agreement for a total amount of US \$81.00 million to jointly fund with the Japanese International Cooperation Development Agency Overseas Association (JICA ODA) construction of the Kazungula Bridge and Border facilities on 10th February 2012.

3.3.2 African Development Bank (AfDB) -Rehabilitation of the Great East Road (Nyimba to Petauke to Sinda)

The African Development Bank (AfDB) and the Government of the Republic of Zambia signed Credit Agreement



on 20 January 2011 for a total amount of AU 69.36 million to fund the rehabilitation of 114.78 km of the Great East Road from Nyimba to Petauke to Sinda. The Loan became effective on 10 June 2011 and all conditions precedent for the first disbursement was satisfied by 24 October 2011 but there has been delays in completing procurement process for the construction of the road sections, hence nΛ disbursements in 2012. The first release of these funds will be during the first half of 2013.

3.3.3 The Arab Bank for Economic Development in Africa (BADEA) and Saudi Fund - Upgrading of the Kalabo to Sikongo to Angola Border Road

The Arab Bank for Economic Development in Africa (BADEA) and the Government of the Republic of Zambia (GRZ) signed the Loan Agreement for a total amount of US \$46 million to fund the upgrading of the Kalabo – Sikongo – Angola Border Road on 31 July 2010. The Consultancy Agreement to re-design the Kalabo to Sikongo to Angola Border Road was signed between the Road Development Agency (RDA) and the Wanjui/Industrial Engineering and Consulting of Kuwait on 11 August 2011.

The Loan Agreement between the Government of the Republic of Zambia (GRZ) and Saudi Fund was signed on 3 May 2012.

The works will commence in 2013 after completion of the re-design consultancy in the first half of 2013.

3.3.4 DANIDA - Road Sector Program Support, Phase I (RSPS I)

2007, the Danish **Embassy** approved the Road Sector Programme Support (RSPS) II for an amount of K281.08 billion (DKK400.0 million) for the period 2007 to 2012. The main development objective of is RSPS Ш improvement and maintenance of Mongu - Senanga -Sesheke road, district support programmes and institutional support to the Road Sector. The rehabilitation of Mongu - Senanga road, by China Henan, was completed during 2009 as the first part of establishing an improved road link between Mongu and Sesheke.

The consultancy by the University of Zambia to carry out the Environmental and Social Survey on the Mongu - Senanga - Sesheke road and comprehensive materials study along Senanga- Sesheke road were completed during 2009 and the final reports have since been released.



A cumulative total of K242.34 billion as been received under RSPS II, while a cumulative total of K178.34 billion has been disbursed as at 31 December 2012. The main activities undertaken during 2012 related mainly to the community access improvements under district support in the expanded 11 districts in Central (Chibombo and Mumbwa), Eastern (Petauke and Chadiza), Luapula (Mansa and Samfya), Lusaka (Chongwe) and Western Provinces (Kaoma, Mongu, Senanga and Sesheke).

3.3.5 Development Bank of Southern Africa (DBSA) – Upgrading of the Western Corridor Roads of Kabompo – Chavuma, Kalulushi – Lufwanyama and Senanga – Sesheke

The loan of **US \$262 million** was signed between the Agency and DBSA

on 22nd December 2010 for the rehabilitation and construction of three Western Corridor Roads namely Kabompo – Chavuma, Kalulushi – Lufwanyama and Senanga – Sesheke.

The loan disbursements commenced during the first Quarter of 2011. A cumulative total of **K1,314.05 billion**

(US \$244.14 million) and **K1,263.48 billion** were received and disbursed as at 31 December 2012, respectively, with a balance of **US \$17.86 million** not yet received from the DBSA as at 31 December 2012. Completion of the three Roads was expected in 2013.

3.3.6 European Investment Bank (EIB) – Rehabilitation of the Great East Road (Luangwa to Nyimba, Sinda to Katete, Chipata Town and Chipata to Mwami Border Post)

The European Investment Bank (EIB) and the Government of the Republic of Zambia signed a Credit Agreement for a total amount of **Euro 80 million** on 12 December 2011 to fund the rehabilitation of 163.97 km of the Great East Road from Luangwa to Nyimba, Sinda to Katete, Chipata Town and Chipata to Mwami Border Post. The funds will be made available during 2013 upon commencement of implementation.

3.3.7 European Union (EU) – Budget Support Programme

The EU has allocated a total of K457.73 billion (Euro 96.0 million) has been under implementation since 2005, with K401.94 billion (Euro 84.3 million) being allocated specifically to support public expenditures in road rehabilitation and maintenance. The programme contains four budget support annual variable tranches and two fixed tranches.

However, from 2009 to date, there has been no release of funds to the Road Sector.

3.3.8 KfW - Rural Transport for Poverty Reduction in the Southern Province

KFW of Germany signed a finance agreement for the Rural Transport for Poverty Reduction in the Southern Province for a total of **Eur15.68 million** with the Government of Zambia on August 26, 2006. Advertising for some of the works

commenced in 2009 and a total of K5.21 billion were expended on two The consultancy services. consultancy was carried out by Gitec Consult Gmbh, where a total of K4.91 billion (Euro 855,433.23) disbursed for the design of tender documents out of contract for tender process, evaluation and supervision of works totaling K14.68 billion (Euro 2,556,419). The second consultancy was carried out by Stange Consult Gmbh, where a total of K1.54 billion (Euro 269,005.60) was disbursed for the capacity building for small and medium sized contractors involved in the execution of maintenance works whose contract amount is K4.43 billion (Euro771,269).

A cumulative total of **K39.86 million** was received and **K35.40 million** was disbursed as at 31st December 2012.

3.3.9 NORDIC Development Fund (NDF) – Rehabilitation of the Kafue National Park Spinal Road

The Nordic Development Fund (NDF) has made available credit of **K52.70** billion (Euro 8.0 million) to the Road Rehabilitation and Maintenance Project (RRMP).

The Kafue National Park Spinal Road has been divided into two Lots and the works contracts were awarded contracts to two Contractors on 7 September 2011 as follows: Global Construction Limited for Lot 1 the contract sum of **K18.40 billion** and China Jiangxi Corporation for International Economic and Technical Co-operation for Lot 1 the contract sum of **K18.17 billion**, both for a 15 months duration. Both Lots were awarded to one Consultant, Ngandu



Consulting Limited for the contract sum of **K3.12 billion** on 6 December 2011. Works commenced on both Lots during 2012 and a cumulative total of **K12.01 million** was received and **K12.88 million** was disbursed as at 31st December 2012.

3.3.10 World Bank - IDA Road Rehabilitation Maintenance Programme (RRMP) APL I Loan

The World Bank (IDA)'s RRMP support to GRZ under the second 10-year (2004-2013) ROADSIP II has been through the three phase 10 year Adaptable Programme Lending (APL), designed in 2004.

The APL 1's total credit amount of US\$50.00 million was approved under IDA RRMP CR 38660ZA in June 2004. As most of the activities have been implemented, total disbursements were US \$48.87 million as at 31 December 2012. This Credit was extended from the original closing date of 30 June 2012 to 30 June 2014.

3.3.11 World Bank - IDA Road Rehabilitation Maintenance Programme (RRMP) APL I Additional Financing I Loan

The supplemental credit under IDA RRMP APL I Additional Financing CR 38661ZA of **US\$25.0 million** was approved in March 2007. The approval of supplementary financing was carried out at the Government of the Republic of Zambia's request to finance repairs to bridges and river crossings damaged during the 2005 and 2006 floods.

For the IDA RRMP APL I Additional Financing I CR 38661ZA Credit, a total of **US \$15.15 million** had been disbursed as at 31st December 2012, leaving an undisbursed balance of **US \$9.85 million** which includes the Chiawa Bridge funding of **US \$8.70 million**. This Credit was extended from the original closing date of 30 June 2012 to 30 June 2014.

3.3.12 World Bank - IDA Road Rehabilitation Maintenance Programme (RRMP) APL I Additional Financing II Loan

The APL I Additional Financing II (APL I AF II) RRMP CR 4821 ZM Credit with the total amount of **US \$15.00 million** was approved in 2010 and its project effectiveness is on 23rd September 2011. The APL I AF II project scope is for the construction of the Chiawa and Mufuchani Bridges and rehabilitation of the 20km paved road between Lusaka and Chirundu (Km55 to Km75).

A total of **US \$2.07 million** had been disbursed as at 31st December 2012. This Credit was extended from the original closing date of 30 June 2012 to 30 June 2014.

3.3.13 World Bank - IDA Road Rehabilitation Maintenance Programme (RRMP) APL II Loan

The second APL credit with the total amount of **US \$75.00** million was approved on 22 December 2009 and became effective on 23 September 2010. The APL Phase II project scope is the rehabilitation of the 51km paved road between Lusaka and Chirundu (Km4 to Km55), construction of Mufuchani Bridge in



Kitwe and various capacity building activities for RTSA and other Road Sector Institutions.

A cumulative total amount of **K59.87** billion (US \$11.49 million) was received and a cumulative total of **K0.39** billion (US \$0.16 million) was disbursed as at 31st December 2012. This Credit closes on 30 June 2014 and most of the planned activities are expected to be implemented during the remaining period.

3.4 FORECAST MOBILISATION AND IMPLEMENTATION OF PROJECTS FROM LOCAL RESOURCES DURING 2013

3.4.1 Local Link Zambia 8,000 Project

The Link Zambia 8,000 Project Phase I estimated at **K11.14 trillion** with a total of 2,534 km will continue to gather momentum during 2013.

3.4.2 Pave Zambia 2,000 Project

The Pave Zambia 2,000 Project equipment is expected to be received during 2013 for commencement of the Project in all the ten (10) Provinces of Zambia.

3.4.3 Lusaka 400 Project

The Lusaka 400 Project is expected to commence fully during early 2013 covering most Lusaka Urban Roads.



3.4.4 Tolling Programme through Road Development Agency (RDA)

The Tolls Act No. 14 of March 2011 gives the RDA the mandate to implement the National Road Tolling Plan. The RDA commenced implementing the Tolling policy by reorganizing its staffing structure and levels to create a Tolling Unit and is likely to commence tolling implementation during 2013, with the resulting tolls revenue channeled to the Road Fund under the NRFA.

3.4.5 Construction Finance Initiative (CFI)

The memorandum of understanding (MoU) between the Road Sector and individual commercial banks will be signed during 2013 and full implementation of this Initiative is expected during 2013.

This will enhance capacity in the local contractor base and also increase the number of big contractors. The combined effect of these factors is increased funding mobilisation from the private sector participation and investment in the Road sector Industry and increased competition resulting in reduced Unit Rates.

3.4.6 Training of small and medium contractors by National Council for Construction (NCC)

The NCC has been allocated **KR5 million** in the 2013 AWP by NRFA to continue the training programme of small contractors and persons in 2013.

3.5 FORECASTED MOBILIZATION AND IMPLEMENTATION OF PROJECTS FROM EXTERNAL RESOURCES DURING 2013

3.5.1 JICA ODA Loan – Construction of the Kazungula Bridge

The Japanese International Cooperation Agency Overseas Development Association (JICA ODA) and the Government of the Republic of Zambia was in the process of signing a Credit Agreement for a total amount of **US \$51.00 million** to jointly fund with the AfDB the construction of the Kazungula Bridge.

Construction of the Bridge was expected to commence during 2013.

3.5.2 EXIM Bank of China – Upgrading of the Nakonde – Mbala Road

The EXIM Bank of China and the Government of the Republic of Zambia was in the process of signing a Credit Agreement for a total amount of **US \$180 million** to fund the upgrade of 180 km of the Nakonde – Mbala Road as at 31 December 2012.

3.5.3 Tripartite Trust Fund

The Government of the Republic of Zambia and Tripartite comprising the Common Market for Eastern and Southern Africa (COMESA), The East African Community (EAC) and The Southern African Development Community (SADC), in collaboration with various donors signed the Grant Agreement for a total of US \$29.76 million to finance the Lusaka -Chirundu Road Link 4 and Kafue 19th weighbridge March 2012. Disbursement of the Grant is expected during 2013.



4.0 INTERNAL AUDIT

In line with its key mandate Internal Audit continued to provide assurance services to the Board and management with the objective of improving the organization 's internal controls, risk management and governance systems.

4.1 ACTIVITIES DURING THE YEAR

For the period under review the following major activities were undertaken by the department:

4.1.1 Quarterly Audit Reports

All the scheduled four quarterly meetings of the Audit & Risk Management Committee of the Board were held as planned and Quarterly reports were presented by the department.

All significant issues raised were subsequently escalated to the Board for its intervention.

4.1.2 Audit and Risk Management Manual

To fully entrench a risk management system in the organization, a manual was developed and approved by the Board.

This will entail that a risk based approach is used when conducting audits resulting in a more focused and cost effective audit.

4.1.3 Joint Audits with RTSA and RDA

As part of efforts to enhance Inter Agency coordination in the road sector, joint audits were conducted for the first time with RTSA. This was in addition to the regular joint audits with RDA.

The aim of these audits was to ensure that all revenues raised by the sister agencies accrued to the Road Fund in accordance with the statutes.

4.1.4 Audit of Local Road Authorities (LRAs) and Others

During the year, disbursements were made to thirteen (13) LRAs for the Community Access Improvement Projects (CAIP) financed by the Royal Danish Embassy. The purpose of the CAIP program is to improve community access points which are regarded as economical and socially helpful.

As part of efforts to ensure value for money, Financial and Technical Audits (undertaken in conjunction with Monitoring and Evaluation Department of NRFA) were conducted.

A number of significant audit issues were raised which resulted in NRFA conducting Capacity Building Workshops for four LRAs. These workshops would be extended to cover the rest of the LRAs in 2013.

Audits were also carried out on Institutions that had received funding for various capacity building activities. These included National Council for Construction (NCC) and the Zambia Institute for Policy Analysis and Research (ZIPAR).



4.2 PROJECT INSPECTION VISITS

The Audit Department together with the Monitoring & Evaluation Department intensified their inspections of various road projects around the country.

4.3 PRE-AUDIT OF PAYMENT CERTIFICATES AND ADMINISTRATION EXPENSES

Routine work of pre auditing payment certificates and administration expenses was also conducted.

4.4 WAY FORWARD

The audit of LRAs will be intensified to ensure that all funds are being utilized for the intended purposes. This will be coupled with capacity building workshops to enable Councils improve accountability and service delivery.

More Joint audits with the two sister agencies will also be conducted in addition to enhanced physical inspection of projects.



5.0 MONITORING AND EVALUATION

5.1 **PROJECTS DURING** ROAD THE **PERIOD UNDER REVIEW**

By 31st December, there were 316 road projects (267 were carry-over from 2011 and 49 were new ones initiated in 2012) that were funded through the National Road fund Agency with a total value of outstanding works worth about K5,831 billion running. This amount included one GRZ funded project (Kasempa Turn-off - Kabompo Section of Road M8) which was initially denominated in US Dollars but later converted to Kwacha equivalent of slightly over K70 billion.

Two other namely projects, Upgrading of Mongu - Kalabo and Nakonde - Mbala were funded directly by the Ministry of Finance (funding did not pass through the National Road Fund Agency) with special loans from China.

5.1.1 **Carry-over Contracts from 2011**

Out of the 316 road projects that were running during the year, 267 projects with outstanding works worth about K4,203 billion were carried over from 2011 to 2012.

By the end of December, 2012, only 19 projects were fully completed. The remaining 247 projects were carriedover to 2013.

5.1.2 Contracts Awarded or Initiated in 2012

From January to end of December 2012, a total of 40 new contracts were submitted to NRFA by the RDA and Local Road Authorities with a total value of about K1,895 billion.

The new contracts are categorized as follows:

- i) 5 contracts for routine maintenance covering 209.00 Km and worthy about K1 billion;
- ii) contract 6 for periodic maintenance covering 645.80 Km and worth about K438 billion;
- iii) rehabilitation contracts covering 74.15 Km and worth about K409 billion;
- iv) 4 upgrading contracts covering 198.40 Km and worth about K894 billion:

- v) design and works 11 supervision contracts worth about K65 billion;
- vi) 7 emergency repair works contracts worth about K20 billion:
- vii) 10 bridge/structure construction contracts worth about K71billion; and
- viii) 2 Equipment procurement contracts (Pave Zambia 2000) worth K12 billion.

Annex 2 contains details of contracts or projects carried-over from 2011 to 2012 as well as projects procured in 2012.

In the annex, projects carried-over from 2011 to 2012 have cumulative expenditure since the project commenced to end of December, 2012 'Total Expenditure to date' column greater than 'Expenditure in 2012' column. On the other hand, projects procured in 2012 have 'Total Expenditure to date' column equal to 'Expenditure in 2012' column.

Contracts Terminated 5.1.3

Two Formula 1 or Accelerated Urban Roads Rehabilitation Projects, Lot 4 and Lot 5 for Mufulira and Ndola, respectively and two Upgrading Projects for Congo Pedicle Road and Landless Corner - Mumbwa Road, Lot 1 were terminated by the RDA and brought to the attention of the Funding Agency (NRFA).



5.2 CERTIFICATES

From 1st January to 31st December, 2012, more than 1,500 payment certificates worth more than K1,628 billion from GRZ, DBSA Loan and Road Fund funded projects passed through M&E Department for review and recommendation for payment.

5.3 INSPECTIONS

Major projects inspected in 2012 are categorised in Urban Roads (one category) and Trunk, Main and District Roads (another category). Details on these road projects such as project names, contract sum, length of road under contract, expenditure up to the end of December, 2012 and progress (percentage completion by end of December, 2012) can be viewed in Annex 3 in addition to observations made on site during inspection as high-lighted below.

5.3.1 Urban Roads:

During inspections of urban roads rehabilitation projects, it was observed that contractors were generally behind schedule on most contracts. Some defects such as uneven surface, defective road studs (cat eves) were observed and presented to RDA for further follow up and correction prior to contractors handing over such roads. Most contracts except for Lots 4, 7 and 11 were running behind schedule for a greater part of the year 2012. Extension of time was granted by the client, RDA and currently all the contracts are substantially completed except for Lot 5 in Ndola which was terminated due to poor performance by the Contractor, Fratelli Locci. Lot 2 in Mufulira, under Fratelli Locci was also terminated.

The Periodic Maintenance of 45 km of selected roads in Lusaka which commenced in 2008 attracted a lot of concerns due to major defects observed on site barely three 3 years after completion and the implementing Agency pursued the matter with keen interest and had the defects corrected during the year under review.

Board members inspected the URRP projects on the Copperbelt in October 2012.

The contract for upgrading of the Leopards Hill to Katoba Basic School under Link Zambia 8000 was on-going with major works being executed in 2012, being earthworks. Variations were issued to the contract to include the Alick Nkhata — Nangwenya—Arcades Road Link, the access road to



Nkoloma Stadium and UNZA roads which lead to the sports facilities that were used during the Africa Zone Six games.

Trunk, Main and District Roads 5.3.2

Inspection of some major projects on Trunk, Main and District Roads was conducted in two parts. One part involved Board Members and the other part was done by members of staff of the National Road Fund Agency in conjunction with the Road Development Agency staff.

i) **Board Site Inspections**

Teams of Board Members were taken on tours to Western and Part of Southern Provinces. Between 19th and 21st of April 2012, a team of Board Members was taken to Western Province to inspect construction of Sesheke - Senanga Road Lots 2 and 3. Among other activities, the Board Members were also taken to selected roads in Southern Province.

These included the Batooka - Mamba Road to inspect the just completed emergency works on that road and Chisekesi - Gwembe Road which was earmarked for emergency pothole repairs under Force Account by RDA.

Board Members were generally with the progress of works being by China Geo-Engineering tion on Lot 3. They were also to note that China Jiangxi had improved the pace of work on Lot 2. The team learnt that works by China Jiangxi would still be completed late, and that RDA had approved Extension of Time.

On Batoka – Maamba Road, the Team was not happy with failures on sections that had been repaired recently. They also called for strengthening of the Bailey Bridge at Km 11 from Batoka by constructing concrete abutments. Further, they noted that mountain side slopes were not stable as loose material was falling and blocking the road.

On Chisekesi – Gwembe Road, the team was not impressed that, in spite of the NRFA's release of over K500 million to RDA Southern Province Regional Office, there were still no works done on the road by the time of inspection. It was learnt, though, that procurement thresholds for the Regional Engineer were too low to expedite works and, therefore, they were channelling their procurements through the Provincial Administration Procurement Committees which had higher procurement thresholds, hence the delays.

Between 14th and 16th of June 2012, a team of Board Members was taken to Western Province. Among the roads inspected were:



- Sessheke Senanga Road Lot 1, by China New Era
- Mongu Kalabo Road, by AVIC
- Lusaka Mongu Road, Force Account by RDA Western Province.

The team was impressed with the works being executed by China New Era on Lot 1. The missing bridge at Sioma was noted as the main challenge to the timely completion of the project. On Mongu – Kalabo Road, the team urged the contractor to accelerate the project execution and ensure that a quality and durable product was done as the public expectations were high.

The Force Account road maintenance works by RDA Regional Engineer from Tateyoyo to Kaoma were seen to be progressing slowly. The Regional Engineer was further advised to ensure that potholes were sealed with premix.

ii) Joint Road Inspections with RDA

A number of routine road inspections were also carried out in various provinces in conjunction with the Road Development Agency. These included:

- Southern Province: Bottom Road, Choma – Chitongo Road, Agricultural Development Support Project (ADSP) in Choma, Batooka – Maamba Road;
- Central Province: Mumbwa –
 Landless Road, Serenje Mukuku
 Bridge, Nasanga Farm Block Roads;
- Luapula Province: Mukuku Bridge to Mansa, Pedicle Road, Chembe – Mansa Road and Mansa – Nchelenge Road;

- Eastern Province: Great East Road, Chipata – Mfuwe Road, Chipata – Lundazi Road, Agricultural Development Support Projects in Lundazi, Katete and Chipata Districts, and Chipata Township Roads;
- Copperbelt Province: Kalulushi Lufwanyama Road;
- Northwestern Province: Kasempa Turnoff – Kabompo Road, Kabompo – Mumbeji Road, Mumbeji – Zambezi Road, Zambezi – Chavuma Road; and
- Western Province: Mongu Kalabo Road, Kalabo – Sikongo Road and Senanga – Sesheke Road

The Kalulushi-Lufwanyama Road Project was behind schedule and required extending beyond February 2013 which was the contractual completion date.

The Mongu-Kalabo Road (Mongu Tapo section) was under construction by AVIC International and funded directly by the Ministry of Finance. The section of the road from Tapo to Kalabo which was constructed some years back under a different contract was also inspected and some notable failures were observed which were reported to RDA for possible repair by variation order to the current contract under AVIC. Part of the Kalaboo – Sikongo Road was also inspected prior to commencement of the works.

Progress on the Bottom Road, Chipata – Mfuwe Road, Chipata – Lundazi Road, and Chembe – Mansa Road was noted to be



exceptionally slow and unsatisfactory, with Chipata – Mfuwe Road showing signs of quality compromise in some sections that the Client (RDA) was advised to pay particular attention to and ensure that they were attended to before the Contractor hands over the road.

Stripping problems on Serenje - Samfya -Mansa Road were noted to have been resolved and surfacing works completed. The Contractor, China Geo-engineering (CGC) was also experiencing problems with the surfacing works stripping on the Mansa - Nchelenge Road Project and was advised to ensure that the problem was resolved before handing over the road to the Client.

Mumbwa Landless Corner Road Lot 2 was completed during the year but there was a problem of surface roughness which, in some instances, seemed to go beyond acceptable limits. The Client (RDA) was advised to ensure that the Contractor corrects the defects prior to handing over of the finished road.

On Choma - Chitongo Road, three crossculvert points had been eroded and required urgent attention to avert possible cut-off of the road. The Road Development Agency earmarked this particular section for emergency repairs under contract.

The Pedicle Road contract for Fratelli was terminated and a new contract awarded to Copperfield Mining Services with effect from November 1, 2012.

The Senanga - Sesheke Road under Lots1, 2 and 3 contracts was also inspected. Lots 1 and 3 were progressing well. Lot 2 was however behind schedule.

All other projects were progressing well.

TECHNICAL AUDIT OF COUNCILS 5.4

Following approval of funds to audit the Community Access Improvement Project (CAIP) by DANIDA, the M&E department undertook Technical Audits of twelve (12) District Councils that were recipients of the initial DANIDA funding. The exercise was done jointly with Internal Audit and Fund Management who focused on Financial Audit while the M & E focused on technical audit.

During the audits, it was generally noted that some Councils lacked adequate and experienced staff. This manifested in the way some of the drainage structures were poorly designed. It also came to light that community participation generally poor in Councils that did not the community reward members by letting them supply various construction materials at a fee. In such Councils, projects were poorly finished, and no sense of ownership appeared to prevail. That has posed a challenge to future maintenance of the drainage structures build. In general, no specific standards appear to have been adhered to.

In Councils where enterprise was a norm, superb drainage structures were constructed, following, primarily, RDA standards for pipe and box culverts. These structures showed their capability to last long and serve the community well. This was evident Councils which used either Contractors or a combination of contracting and Force Account to execute the works. Such Councils included Gwembe, Chadiza, Petauke, and Senanga. Although Mansa was



purely Force Account, it stood among success story of Councils aforementioned. In cases where no skills were available in the Council, like Chadiza, the Council exploited the strength of skills available at the District Education Board and District Department of Works.

5.5 TECHNICAL AUDIT OF PRIORITY RIVER CROSSINGS IN NORTHERN AND LUAPULA PROVINCES AND 4 **NATIONAL PARKS**

Following the World **Banks** requirement that an independent technical audit of the Construction of Priority River Crossings in Northern and Luapula Provinces and 4 National Parks financed by the Bank be undertaken, a consultant (K & Associates Professional Services Limited in association with G-PES Limited and E.G. Pettit & Partners) was procured in December 2011 and Contract Agreement between NRFA and the Consultant signed on 17th January, 2012.

5.6 PARTICIPATION OF NRFA IN OTHER **ROAD SECTOR PROGRAMMES**

The NRFA made useful input in the revision of the ROADSIP II Addendum II document. The Agency fully participated in the development of the road sector framework and implementation strategy. The framework sets out GRZ direction for the road sector. The NRFA also participated in capacity building of Local Road Authorities and provided technical support to RDA on other programmes such as L400 and Link Zambia 8000.




A Good and Safe Road Network
